The only full-time faculty member is retiring and will not be returning for the Fall 2024 semester. A recruitment is under way with final interviews scheduled for April 2024.



A. General Enrollment




The Program has seen a 7.4 % decline in enrollment in the years 2022-2023. By contrast, the College has seen a 3.25 % increase. This decline is consistent with the overall trend in industry. The Criminal Justice Advisory Committee members advise that all across the State (and Country) law enforcement agencies are having difficulties filling open positions. They have been spending a great deal of time and resources to figure out how to reverse this trend and attract people back to a career in law enforcement.

B. General Student Demand (Fill Rate)

Fill Rate: The ratio of enrollments to class limits. Cross listed class limits are adjusted appropriately, Also, courses with zero class limits are excluded from this measure.

The College fill rate has remained steady at 76% and the Criminal Justice Program fill rate dropped from 78% to 72% in the last year. I took a look at the individual course fill rates for 2022-2023 to see if a specific course or courses are bringing down that number. The course fill rates for 2022-2023 are as follows:

CJ 202: 93.5%
CJ 204: 65%
CJ 206: 54%
CJ 208: 33.75%
CJ 210: 78.75%
CJ 213: 125%
CJ 224: 93.75%
CJ 226: 32.5%


CJ 228: 55%

In light of these numbers, future schedules may want to alter the CJ206 offering to once a year not every semester. In the past it was offered twice a year, unlike CJ204, CJ208, CJ213, CJ226 and CJ228, which are only offered once a year. The additional offering was because many paralegal students took the CJ206 course. Cross checking the paralegal pattern and paralegal enrollments may indicate that offering this course once a year is sufficient.

Moreover, CJ 208 and CJ 228 are remaining in a downward enrollment trend. ADT students can take either course to satisfy their degree requirements but do not have to take both. It appears that the students are splitting between the two and a discussion at the Advisory Committee level should be had about discontinuing offering one or the other if fill rates are a concern.

CJ226 has also been low enrolled and is not part of the ADT pattern but required for the Criminal Justice AA degree. The idea of eliminating this course in past discussions with the Advisory Committee has not been well received. They believe that report writing is one of the most critical skills that aspiring law enforcement officers can be taught. Additional conversation should probably occur.

C. General Efficiency (FTES/FTEF)





College efficiency for 2022-2023 is 11.77 and for the Criminal Justice Program is 12.48. With class caps set at 40 for all courses, the Criminal Justice program remains as efficient as the College wide standard despite low fill rates for some courses.






The 2022-2023 College wide face to face modality success rate is 79.99% and the Criminal Justice Program is 67.42%. So, the Criminal Justice program's success rates in the face-to-face modality are significantly lower than the College. This is troubling because in the prior five years, the lowest face-to-face success rate for the Criminal Justice Program was 75.57%. This should be monitored to determine if this year was an anomaly.

In the online modality, the 2022-2023 success rate is 72.07% for the College and is 74.91% for the Criminal Justice Program. So the Criminal Justice Program is above the College on this data point.

E. Degrees and Certificates Awarded

In the year 2022, a total of 46 Administration of Justice/Criminal Justice degrees were awarded. 27 ADT's and 19 AA's were awarded. The year 2023 demonstrated a significant drop in the total from 46 to 31.

In the academic year 2022-2023, the Criminal Justice Program's successful course completion rate was 71.35%. This is four percentage points below the College's baseline standard of 75.97%.

The disaggregated data is discouraging. The performance gaps for the student populations above indicate programmatic increases from 2021-2022 to 2022-2023 in all listed populations except Aged 20-24 and female students. Moreover, the criminal justice program performance gaps exceed the College wide averages in all listed populations except Academically Disadvantaged.

The good news is that the program has eliminated the performance gap for Foster Youth that 18.25% in 2021-2022 and is at 10.97% for the College. This is significant as reducing the performance gap in this population was a focus of the IPPR last year. Moreover, the program has eliminated the performance gap for Promise Students that was 4.06% in 2021-2022 and is at 4.47% for the College. And has eliminated the performance gap for Ethnicity identified as Two or More Races that was 12.85% in 2021-2022.

Hopefully, the hiring process for the new instructor, which includes an emphasis on equity, will be a step toward reducing these performance gaps. In addition, instructors will continue to be encouraged to get professional development around equity issues. The College can assist by making equity training available.

A recruitment for a new full-time faculty member is underway. This individual will likely have thoughts about curriculum development and how to promote equity, student success persistence and retention. In that regard, in anticipation of this departure, all of the criminal justice courses just went through content updates that were approved in the Spring of 2023. The Course Outlines of Record should be in good shape for the next full-time faculty person.

Another potential challenge is that enrollment appears to be on the decline. Whether this is a short-term trend or the result of societal factors remains to be seen. However, local law enforcement agencies have been reporting that they have many vacancies without hopes of filling them because of a lack of applicants. They indicate that this is a statewide problem.

The most recent CTER data bears this out. According to the California Employment Development Department, there are 336,560 annual job openings in the State of California in the occupation profiles associated with Criminal/Administration of Justice. There are 1,650 annual job openings in San Luis Obispo County. (See Charts below)

Just three years ago, the vacancy numbers were a fraction of those. In 2021, according to the California Employment Development Department, there were 31,270 annual job openings in the State of California in the occupation profiles associated with Criminal/Administration of Justice and 130 annual job openings in San Luis Obispo County. The same SOC codes were used.
