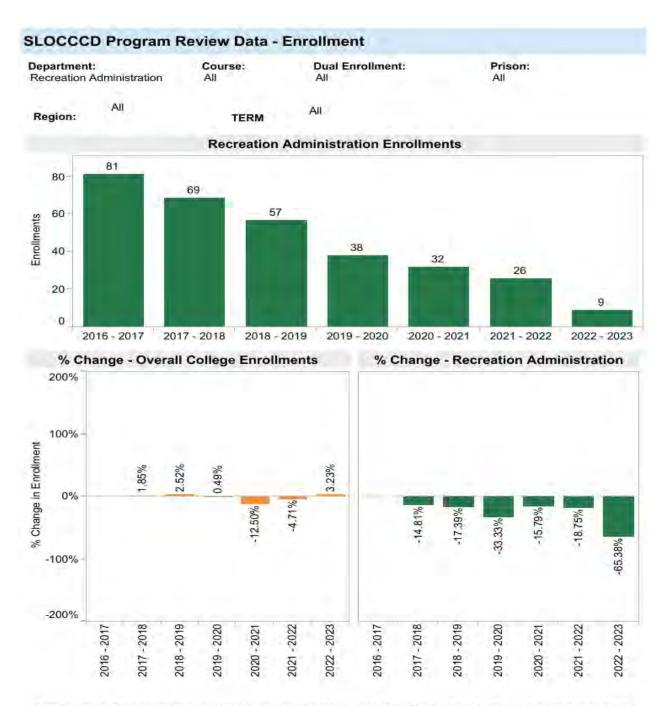

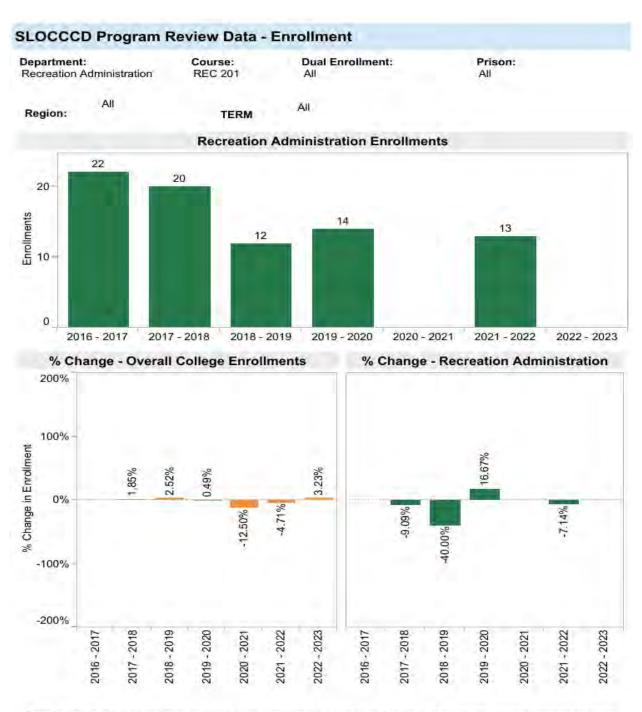
Recreation Administration Overall Program Enrollment which includes REC 201, 203, 204, and 205



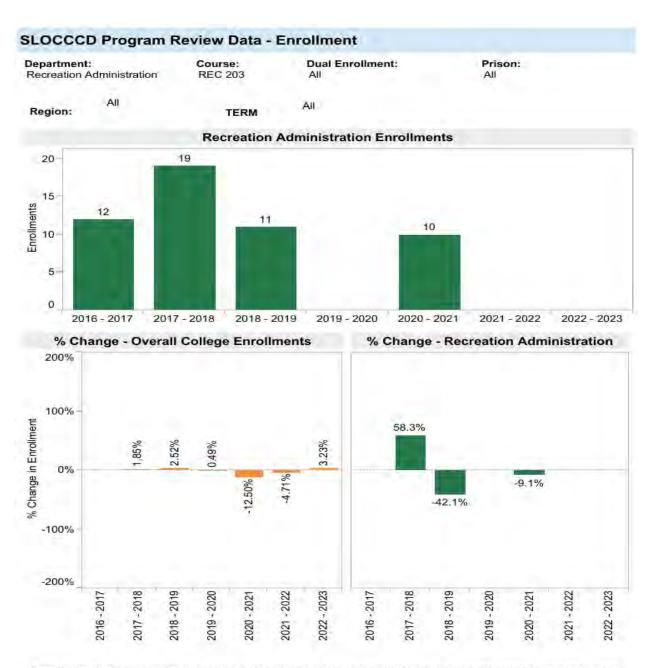

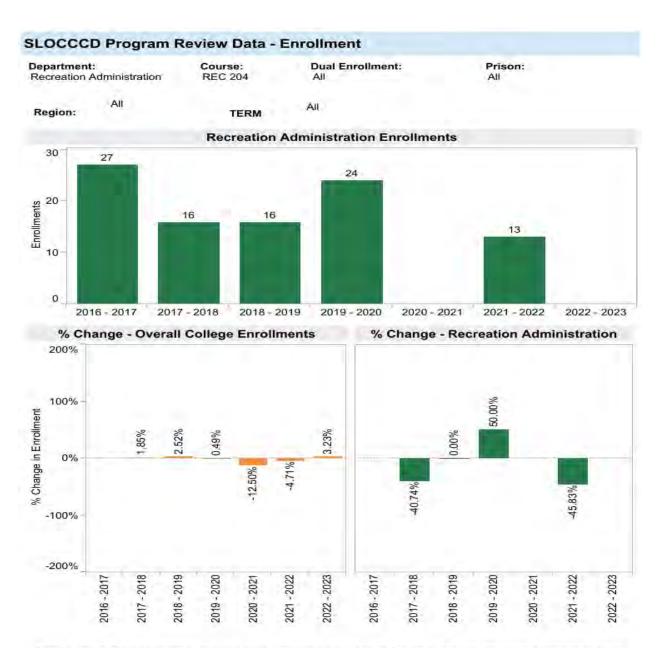

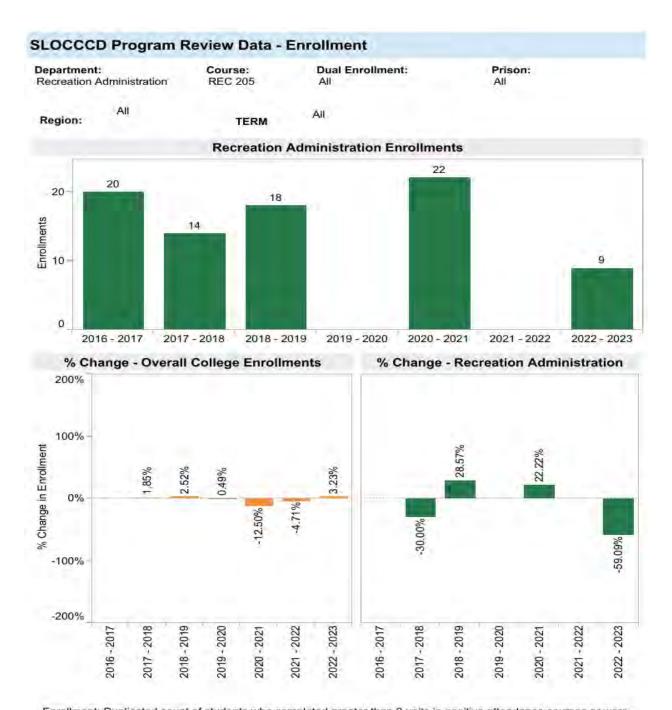
## **REC 203: Sports Programming Enrollments**

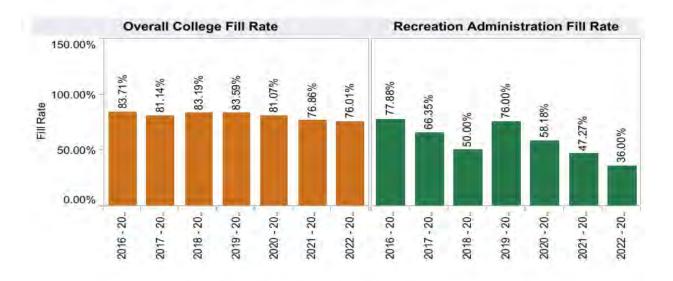

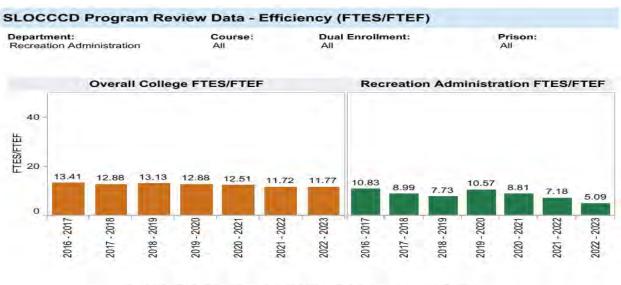

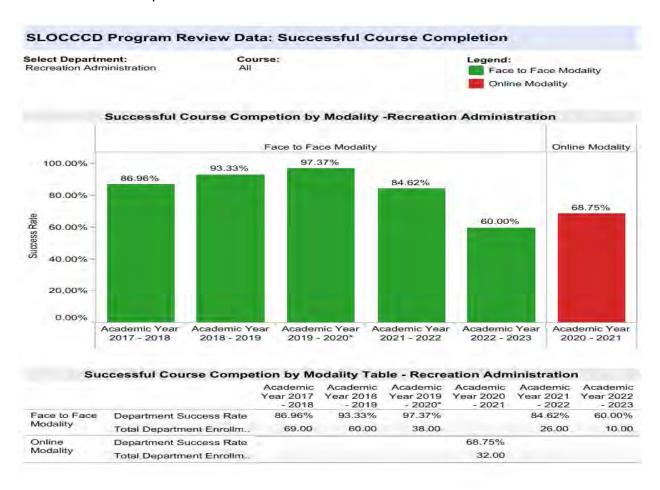
The graph above shows general efficiency is down at 5.09 while the college is at 11.77.

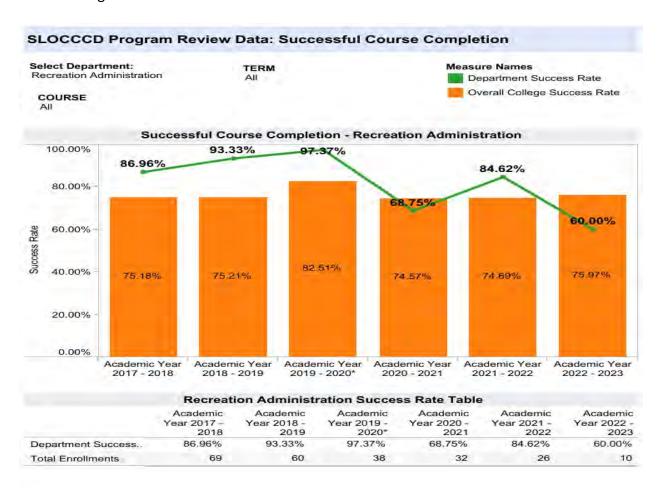


Program Awards: The number of degress and certificates awarded by program type

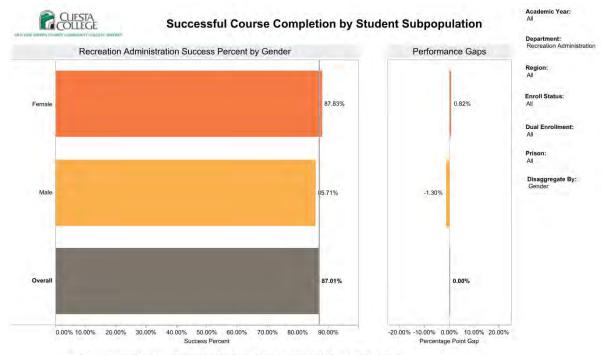
